#### Wood County Master Gardener Volunteers Position Description

Title: Wood County Master Gardener Volunteer Mentor

Purpose: To help new trainees smoothly adapt to the Master Gardener Volunteer Program, build fellowship within the program, and assist in the retention and involvement for a First Year Master Gardener in the program.

#### Responsibilities or Duties:

- Maintain contact with assigned trainee through First Year Master Gardener tenure.
  - a. Contact assigned mentee as soon as possible. Provide name and phone number so they may contact you with questions. Consider adding them to social media.
  - b. If possible, attend the first Level 1 training class and introduce yourself.
  - c. Midway through Level 1 training, check in the mentee. Do they have any questions regarding training? Testing?
  - d. Once Level 1 training is complete, invite trainee to monthly members meetings. Be certain they understand where the meeting location is and directions if needed. Introduce them to other Master Gardeners at the meeting.
  - e. Discuss possible projects and committees the trainee may be interested in. Introduce them to the leaders or chairs of those projects. Connect the trainee with upcoming work days or committee meetings.
  - Be sure they are on the newsletter mailing list.
  - g. Be sure they know the Wood County Master Gardeners website, and what is found in the members only area. Review that it is important if they use a public computer (Library) they need to log out each time they go to the website.
  - Show them the Wood County Master Gardeners' Facebook Group and Page.
  - Check in once a month throughout the year. Is the trainee aware of upcoming events, such as plant sales or garden work? Are they aware of deadlines, such as project proposals and Online Reporting System (ORS).

#### Skills/Knowledge Needed:

- Certified and active Wood County Master Gardener.
- Good Communication skills.
- Be familiar with Wood County Master Gardener Volunteer (WCMGV) organizational activities and committees.

#### Resources Available:

- Trainees will fill out an interest survey and be matched up with mentors based on geographical location and interests.
- If there are serious concerns about a mentee, personality conflicts, or other problems, mentors are to pass this information to the program coordinator. It is not the mentor's duty to get involved in any major conflict resolution.

## Marshfield Children's Festival Report

The Wood County Master Gardener volunteers again were in place to represent the organization at the annual Marshfield Children's Festival.

Our preliminary meeting in February included discussing new ideas and duties. Our next meeting was prior to our membership meeting in March. There, we assembled single packets of Sugar Sprint peas, Jack-be-little pumpkins and Royal Burgundy beans and began working on the sunflower seed kits (about 750) for this year's event. A number of people took 100 seed packets home to assemble and return to us.

The directions for growing the sunflowers were refreshed since there apparently was a concern over molding inside the closed sandwich bag. Some new displays and signs were made to attract attendees.

On the Friday before the Festival, we set up the booth in about 20 minutes. On Saturday, April 13, we handed out many seed packets to children and their parents. They were well received. Also on hand were a number of brochures related to upcoming gardening events, community garden information and Master Gardener volunteer information. We also answered numerous gardening questions.

Any leftover seed packets or kits were given to the Pittsville Historical Society and Point Bass Historical location to hand out to children's groups. Finally, a thank you note was sent to Provision Partners for their sunflower seed donation.

#### **Book Review**

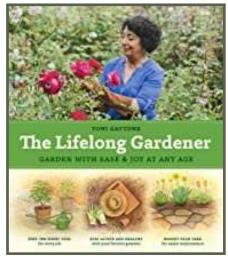

#### Level 1 Training

Level 1 Training will run between January 14<sup>th</sup> -April 7<sup>th</sup>, Tuesday evenings from 5:30-8:30PM. The cost is \$125. Classes will be held at the Town of Wood Hall in Pittsville. If you know anyone who is interested, please forward them Janell Wehr's contact information. Also, if you know of a place to hang a recruitment flyer, please stop by the Extension office and pick up the marketing materials.

#### Enrollment!

The move to Madison has resulted in some new requirements for all Extension volunteers. Each of these requirements revolve around the issue of liability and insurance. All Extension volunteers will need to annually review and electronically "sign" the Volunteer Conduct Agreement, Assumption of Risk, Consent to Emergency Treatment, and opt in or out of the photo release. You may refer to a copy of this document on the following page. These are all documents you were required to sign when you initially completed your Level 1 Training, so they will seem familiar to you. The good news is the "Enrollment" process is simple. You'll just need to log into ORS, the same website where you report your hours. Once you log in, you'll be prompted to review and check a box if you agree. Once the boxes are checked, you'll be all set to volunteer for another year. This year the deadline to enroll is February 1st, 2020. The enrollment process should be ready in ORS after December 1st. #### Volunteer Conduct Agreement

Families, individuals, and organizations trust the University of Wisconsin-Extension to provide quality leadership and care for those who are involved in Extension-sponsored programs. The opportunity to work as a volunteer with Extension is a privileged position that should be held only by those who are willing to demonstrate behaviors that fulfill this trust.
All Extension volunteers are required to complete the Extension Youth Protection program. This in-

cludes: 1) a background check for arrest and conviction records, 2) participation in a volunteer orientation program, and 3) signing the Volunteer Behavior Expectations form. The primary purpose of this process is to ensure the safety and well-being of all participants (i.é., youth, adults, salaried and volunteer staff)

Extension volunteers are expected to abide by the following behavior standards established by Extension and to conduct themselves as positive role models for program participants. All Extension volunteers are ultimately accountable to Extension for their Extension related activities.

As a Extension volunteer, I will:

Cooperate with and support Extension staff to jointly further the mission of the Extension. Accept supervision and guidance from Extension staff or designated management volunteers. Conduct myself in a manner that is in the best interest of program participants and Extension and will not use the volunteer position or title for purposes of private or personal gain.

Use appropriate University research-based resources/information.

Make all reasonable efforts to ensure that programs are accessible to all individuals regardless of race, color, sex, creed, disability, religion, national origin, ancestry, age, sexual orientation, pregnancy, marital or parental status.

Abide by all local, state and federal laws and Extension and U.S.D.A. rules, policies and guidelines. Conduct myself with courteous manners and language, exhibiting good sportsmanship, serving as a positive role model, treating others with respect, and demonstrating reasonable conflict reso-

Not consume or be under the influence of alcohol or illegal substances while in the role of a Extension volunteer, nor allow youth participants under my supervision to do so.

When transporting youth or adults, operate motor vehicles and other equipment in a safe and reliable manner and only with a valid operator's license and the legally required insurance. I will comply with all motor vehicle related state regulations and laws.

Treat animals in a humane manner and teach program participants to provide appropriate animal care and management.

Report suspected verbal, sexual, physical abuse and neglect of youth to local authorities.

Not conceal carry firearms and/or weapons while acting in a volunteer role. I understand that if I am a 4-H Youth Development shooting sports volunteer, I am expected to openly carry/ transport 4-H shooting sports equipment in designated areas.

Immediately notify my county Extension Educator/Agent of any changes with my status (e.g. contact information, criminal arrest, charge or conviction history, driving privileges, etc.)

I have read and understand and agree to abide by these expectations for volunteers. I understand that suspension or termination of my position as a volunteer will result if I do not meet these expectations.

#### Assumption of Risk

I understand that not all risks can be foreseen and there are some risks which are unpredictable. I understand there are certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. I am aware of the risks of participation, which include, but are not limited to, the possibility of physical injury, fatigue, bruises, contusions, broken bones, concussion, paralysis, and even death. I understand that the county and university have advised me to seek the advice of my physician before participating in my county's Master Gardener volunteer program. I understand that I have been advised to have health and accident insurance in effect and that no such coverage is provided for me by my enrolled county's UW Extension or the Board of Regents of the University of Wisconsin System. I know, understand, and appreciate the risks that are inherent in the above-listed programs and activities. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

#### Consent to Emergency Treatment

I authorize my enrolled county's UW Extension or the Board of Regents of the University of Wisconsin System and their designated representatives to consent, on my behalf, to any emergency medical/ hospital care or treatment to be rendered upon the advice of any licensed physician. I agree to be responsible for all necessary charges incurred by any hospitalization or treatment rendered pursuant to this authorization

I grant the Master Gardener Volunteer Program, Extension and the University of Wisconsin Board of Regents the right to publish, and copyright my image (including audio, moving image or photography) for educational programs, websites, and promotion of its programs.
