We do not want to lose a MG member and/or a project due to lack of current information about either.

### Our MG Year Just Got Longer!

Just in case you missed the following information in the **VIBE** from Mike Maddox, Master Gardener Program Director in Madison.....

You have an extra 3 months to complete your 10 HOURS OF EDUCATION requirement for 2020!

The Wisconsin Master Gardener year will no longer run from October through September. Instead it becomes a calendar year (January through December) as of 2021. In order to make that happen, the extra months of October through December have been added to 2020. You have a little additional time to accumulate your 10 education hours after the gardening year winds down.

Be sure to enter your education hours on the Online Reporting System for Master Gardeners. Reported hours will be accepted until the end of the year.

Remember that since Master Gardeners were inactive in 2020 because of COVID-19, all members were exempt from the 24 hours of volunteer time normally required each year. However, if you did earn volunteer hours, make sure you report them as well. That information is most welcome by the Madison office.

#### October Garden Guide

from Portage County Master Gardeners Volunteers

• On October 1, start treatment of poinsettias for bract coloration. Place in total darkness for 15 hours every day for 2 months. Night temperature should be 65-70 degrees F. Keep soil moist.

Plant peonies until October 15. Mulch after ground freezes.

- Seed perennials such as Oriental poppy, Iceland poppy, gas plant, primrose, scabiosa, phlox, pansy and penstemon. Mark where planted.
- Plant spring flowering bulbs. Bulbs can be planted up to six weeks after first fall frost. Fertilize existing bulb beds with bone meal, milorganite, or 5-5-5 fertilizer.
- Harvest gladiolas at least six weeks after bloom and before ground freezes. Cure for three days at 80 degrees before storing. Label and store at 40-45 degrees in open trays.
- Remove iris leaves to prevent over wintering of iris borer eggs. Cut leaves to four-inch fans.
- Store tuberose at 45 degrees F, tuberous rooted begonias at 45-50 degrees, and caladium at 60 degrees.
- After killing frost, rose bush foliage should be stripped and old leaves cleaned from bed. Shortly before ground freezes, roses should be given good deep soaking. Prune branches enough to prevent whipping around in wind or to fit under rose cones.

Sow seeds of hardy annuals: cleome, pinks, candytuft, larkspur, bachelor buttons and calendula. Mark where planted.

- Plant Jerusalem artichoke during last two weeks of month.
- Prepare vegetable garden soil for early spring planting. Remove old stalks to prevent insect and disease problems next year. Spread manure, incorporate into soil.

 Rejuvenate rhubarb by dividing into quarters and replanting.

- Cut back asparagus ferns and dispose to prevent insect and disease problems next year. Incorporate manure into soil and mulch with straw.
- Use mulch around Brussels sprouts to moderate soil temperature and prolong harvest.
- Water plants well for more cold tolerance.
- Plant garlic 2-3 inches deep and cover with 4-6 inches of straw mulch.
- Rake, chop and compost any fallen leaves from lawn.
- Fertilize shade trees when leaf color changes and leaves drop.
- Plant dormant deciduous trees and shrubs from now until ground freezes. A two-inch layer of mulch reduces freezing and thawing, which can damage roots.
- If fertilizing lawn one time a year, apply it in the third week of October. If fertilizing twice a year, apply in October and early June. If three times a year, include a September application.
- Water evergreens and foundation plantings before ground freezes.
- Protect woody ornamentals and fruit trees against mice.

#### Ashes to Charcoal

Winter's coming and some of us have wood burning stoves or know people that have them in this rural part of Wisconsin. So the question arises: Can I use the wood ashes on my garden, and if so what kind of ratio per square feet can I safely use it?

This is the research that I found so far.

The learning store has an article that comes up first for <u>using Industrial ash</u> on farmland, which, while it is useful to read doesn't say much about the home garden. Here is what I gleaned from it.

Wood ash can be used in place of lime at about a rate of 2 to 1. It has more micronutrients than lime, but also carries the risk of heavy metal contamination if you do not know what kind of wood the ashes came from. There is a chart in this publication that will give you all the elements they found in samples taken from northern Wisconsin. Yields were moderately to substantially better than nothing.

There are regulations to spreading ash in an agricultural situation as regulated by the DNR.

These regulations concerned me, so I dug a little further and found an article titled <u>Using Wood Ash in the Home Garden</u> revised in February of this year. This publication advises that you only use ash that has come from trees grown in natural areas, as trees from industrial sites may include heavy metals and other contaminates. Do not use ash produced by burning treated wood, waste oil, plastics or garbage for the same reason. Use the wood ash by sifting the ash to remove large charcoal pieces as well as any active embers if you are using the ash while hot. Only apply recommended amounts AFTER you have had a soil test for the area you are planning to use it on. Read the article linked above for more information.

Which leads me to the charcoal mentioned in the title and taken out of the ashes. My sister is a newly minted Master Gardener out in Oregon and has taken to sending me articles that were forwarded to her by her horticultural advisor. One of those nuggets was titled "A Perspective on Terra Preta and Biochar" by Austin Liu.

This whole article is at least a 20-minute read about how the Indians in the Amazon Basin use charcoal to amend soils -creating a self-replicating biochar that has fertilization capabilities even beyond the use of just ash. Not only does it put back, but it creates a soil that sequesters the carbon (helping the environment and aiding plants)

In order to make biochar, you can't just dump the charcoal in the ground. There were experiments that found the optimum results were gotten by adding the activated charcoal to compost piles. It was found that by adding it to the organic matter, the heat generated from a 'hot' compost pile would be sustained for longer periods of time, creating a faster compost with a higher carbon content and fertility value. There was much more to explore in this article, and I would highly recommend reading the whole thing.

I happened to have a couple of pounds of cold activated charcoal from my wood stove sitting around the house that I threw in a small compost pile that I started this year. The apparent breakdown of organic materials into compost did seem to come at a slightly faster pace than my infamous cold compost piles tend to do. Within a few weeks I had a good layer of compost at the bottom and when stirred like it's supposed to be, seemed to further the progress. I did not have a thermometer to keep track and did not keep good records, but the science has definitely intrigued me and plan to do more research in the future.

# Wood County Master Gardener Standard Practice I Community Volunteer Project Classifications

#### Authorized Master Gardener Projects

Garden projects for education and beautification purposes throughout Wood County that are referred to as WCMGV Authorized Master Gardener Projects must meet the following requirements:

- Agencies hosting a project must have non-profit status and/or 501(c) (3) status (for example, city and county owned parks or facilities, public libraries, fairgrounds, municipal buildings, public museums, and schools).
- The project must be chaired or co-chaired by a certified Master Gardener Volunteer.
- The project must be open to the involvement of all certified and/or intern Master Gardener Volunteers who wish to participate. (The project can accommodate and will welcome additional volunteers.)
- The Project Leader(s) will complete a WCMGV Project Authorization and Funding Request Form annually.
- The project will be evaluated annually by the Project Leader(s) and/or team members using the Project Self-Evaluation Form.
- WCMGV Authorized Master Gardener Projects are the only projects on which <u>intern</u> WCMGV's can earn volunteer hours credit.
- Gardens must be accessible to the public.
- Authorized Master Gardener Projects that are also Funded Master Gardener Projects, must meet the following requirements:
  - The project must meet the definition of an Authorized Project.
  - The project must be in good standing based on the Project Self-Evaluation Form.
  - c. The Project Leader(s) shall complete a WCMGV Voucher Form for reimbursement of funds spent on the project by December 1<sup>st</sup>.

#### Funded Master Gardener Projects

The WCMGV Project Authorization and Funding Request Form and Project Self-Evaluation Form must be submitted to the chairperson of the Project Authorization Committee by October 1. The Project Authorization Committee will review the forms/requests and forward them with recommendations for authorization (or not) to the chairperson of the Finance Committee no later than January 15th. The annual budget will be presented to the Board of Directors at the 1st quarter Board of Directors meeting (meeting to be held prior to March Membership meeting) and will contain recommendations for funding amounts for each project request.

#### Wood County Master Gardener Standard Practice II

#### Authorized Project Spending Guidelines

 The Wood County Master Gardener Volunteers will fund the following materials in conjunction with authorized Master Gardener projects:

Seeds, soil amendments, trees, shrubs, potting soil (reasonable quantities) insecticide, mulch, annuals, perennials, fertilizer, weed killer/prevention, plant markers, educational signage, deer/rabbit proofing, garden soil, and special one-time needs.

The Wood County Master Gardener Volunteers will <u>NOT</u> fund the following "hardscape" items and recommend alternative sources for funding be explored by the project leader.

Stone/brick edging, bird baths, tools, hoses, park benches, bird feeders, park grills, picnic tables, garden gloves, flagpoles, flags, paving stone, flower pots, urns, containers retailing over \$30 each.

EXCEPTION: Master Gardener Youth/Adult Grant funds for education projects may use the grant monies for educational materials/garden tools/hoses/materials that will enhance the lesson. This material may remain the property of the educational project.

- The Wood County Master Gardener Volunteers will <u>NOT</u> fund costs of outsourced labor.
- Annually, members will receive copies of Standard Practice I, II, III, and IV, Project Guidelines and the following WCMGV forms: Project Authorization and Funding Request, Project Self Evaluation, Voucher, and Grant Application for Youth/Adult Education.
- Any Project Leader submitting a reimbursement request for non-funded materials will NOT be reimbursed for that portion of the project costs.
- Special requests will be considered, however priority will go to project requests submitted by the deadline (Standard Practice I).
- 7. Exceptions to the above policies must be presented to the Project Authorization Committee (volunteer projects) before action is taken. The Chairperson will forward the exception request to the Board of Directors if an amicable agreement/solution cannot be reached. The Board will make the final decision if necessary.
- If a Self-Evaluation form (for garden projects) or a short article for the WCMGV newsletter publication (for youth/education grants) is not submitted by October 1<sup>st</sup> of current year, funding may be denied.

# Wood County Master Gardener Standard Practice III Volunteer Committees and Teams

Committees/teams shall be established to support and promote the Mission of the Wood County Master Gardener Association. The committees/teams will include, but are not limited to those specified by the Board of Directors. All committee/team material, records, correspondence, etc., will be transferred to new committee/team chairpersons upon appointment. The Board of Directors will select chairpersons for all Standing Committees. A report from each committee/team chairperson should be provided to the WCMGV president upon request.

WCMG Association depends on volunteer officers and committees and teams to organize and manage its operation along with its commitment to the Wood County Extension office and specific community projects.

With the exception of the Board of Directors, committees and teams shall be self-organizing within the volunteer committee/team chairperson's interpretation of organization procedure and policy.

All committees and teams will manage their respective responsibilities in a professional and timely manner. Committees and teams will consult with the Board of Directors or the Master Gardener Advisor as requested or as necessary.

#### Standing Committees

Standing Committees are responsible for the annual operations of WCMG Association.

Standing Committees members shall volunteer or receive appointment as practical.

Each standing committee shall have a chairperson selected by the Board of Directors. Standing Committees will execute their responsibilities in coordination with and support of the WCMGA Purpose and Mission, and WCMGV Board of Directors. (See Bylaws Article II)

<u>Finance</u> – The Finance Committee will consist of the treasurer, president, WCMGV Advisor and one other member of the board of directors. The committee is charged with preparation and review of an annual budget, including volunteer project allocations in accordance with WCMGV Standard Practice I.

<u>Programs</u> – The vice-president and four WCMGV members-at-large are charged with the responsibility of scheduling meetings which include, but not limited to, educational programs, horticultural-related, special-interest site and botanical garden tours. WCMGV Authorized Projects should be emphasized when possible. WCMGV Advisor attends when practical/available.

<u>Project Authorization Committee</u> - The charge of this committee is to provide guidance and authorization of new and existing volunteer garden projects. WCMGV Standard Practice

- If a self-evaluation form for garden projects or a short article for youth/adult educational grant is not submitted by October 1st, funding may be denied for the next year.
- All project/grant forms must be submitted by October 1<sup>st</sup> to Wood County Extension Office 400 Market Street, PO Box 8095, Wisconsin Rapids, WI 54495.
- The WCMGVs Voucher Form is due to WCMGV Treasurer by December 1st.

#### Forms

- <u>Project Authorization and Funding Request Form</u> used for WCMGV projects to be approved by Project Authorization Committee and to request funding for such projects.
- <u>Project Self Evaluation Form</u> completed by Project Chair(s) annually for a selfevaluation of WCMGV project.
- Grant Application for Youth/Adult Education Project completed only if requesting grant monies from WCMGV for youth/adult education projects.
- <u>Voucher Form</u> to request reimbursement for expenses spent on approved WCMGV projects.
- <u>Community Education Request</u> Used by community organizations to request WCMGV assistance for speaking or gardens.
- Checklist for Master Gardener Community Education Project Approval used by WCMGV to assess appropriateness of garden request by community organization.
- Year End Tally of Community Education used by all WCMGV to track number
  of contacts with the public regarding horticultural education.
